

NOTICE OF INTENT TO ENACT ORDINANCE
MILLCREEK TOWNSHIP
LEBANON COUNTY, PENNSYLVANIA
PROPOSED ORDINANCE NO. 041223

NOTICE IS HEREBY GIVEN by the Board of Supervisors of the Township of Millcreek, County of Lebanon, and Commonwealth of Pennsylvania, that it shall consider proposed Ordinance No. 041223 at its regularly scheduled meeting on Wednesday, April 12, 2023, and subsequently, if appropriate, at that meeting or at a subsequent public meeting held within 60 days of the date of publication of this notice, may enact an ordinance the title of which is as follows:

AN ORDINANCE AMENDING SECTION 2 OF ORDINANCE NO. 2/10/99-A, INCREASING THE FEE FROM TEN (10) DOLLARS TO FIFTEEN (15) DOLLARS THAT THE MILLCREEK TOWNSHIP, LEBANON COUNTY, TAX COLLECTOR IS AUTHORIZED TO CHARGE FOR PROVIDING INFORMATION AND WRITTEN CERTIFICATIONS CONCERNING THE PAYMENT OR NONPAYMENT OF TAXES COLLECTIBLE BY THE MILLCREEK TOWNSHIP TAX COLLECTOR.

A brief summary of the Proposed Ordinance is as follows. Section 1 raises the fee the Millcreek Township Tax Collector may charge for providing information, oral or by written certification, concerning the payment or nonpayment of taxes collectible by the Millcreek Township Tax Collector to parties interested in the sale and purchase of real estate from ten (10) dollars to fifteen (15) dollars. Section 2 confirms, that in all other respects, Ordinance No. 2/10/99-A remains in full force and effect. Section 3 provides an effective date.

Copies of the full text of Proposed Ordinance No. 041223 may be examined without charge or may be obtained for cost thereof at the Millcreek Township Municipal Building, 81 East Alumni Avenue, Newmanstown, PA, between the hours of 7:30 a.m. and 3:30 p.m. Monday through Friday, prevailing time, excluding holidays.

It is anticipated that final action will be taken on this proposed ordinance at the meeting of the Board of Supervisors on Wednesday, April 12, 2023 at 7:00 p.m. at the Township Building, 81 East Alumni Avenue, Newmanstown, Pennsylvania.
