ORDINANCE NO. 121708

AN ORDINANCE ESTABLISHING A MAXIMUM SPEED LIMIT OF TWENTY-FIVE (25) MILES PER HOUR FOR PORTIONS OF EDGEMONT LANE (T-655), CENTRAL DRIVE (T-645), COTTAGE LANE (T-647), GARDEN DRIVE (T-449), MORGAN DRIVE (T-660), A PORTION OF TREELINE DRIVE (T-651), A PORTION OF SWEETWATER LANE (T-663), A PORTION OF EAGLE VIEW DRIVE (T-662), AND A PORTION OF HILLSIDE DRIVE (T-661); PROVIDING FOR SIGNING; AND PROVIDING PENALTIES.

WHEREAS, the Pennsylvania Vehicle Code 75 Pa. C.S. in Sections 6109, 6124, and 3362 specifically empowers Millcreek Township to regulate traffic on streets and highways within the physical boundaries of Millcreek Township, Lebanon County; and

WHEREAS, the Board of Supervisors of Millcreek Township, Lebanon County, desires to improve traffic conditions in the township; and

WHEREAS, the Board of Supervisors of Millcreek Township desires to establish a maximum speed limit of twenty-five (25) miles per hour on portions of Edgemont Lane, Central Drive, Cottage Lane, Garden Drive, Morgan Drive, a portion of Treeline Drive, a portion of Sweetwater Lane, a portion of Eagle View Drive, and a

portion of Hillside Drive without an engineering and traffic investigation, as allowed by amendments to the Pennsylvania Vehicle Code set forth in 75 Pa. C.S. § 3362; and

WHEREAS, the Board of Supervisors of Millcreek Township, Lebanon County, Pennsylvania, finds that Edgemont Lane, Central Drive, Cottage Lane, Garden Drive, Morgan Drive, Treeline Drive, Sweetwater Lane, Eagle View Drive, and Hillside Drive are all in a residence district, are not numbered traffic routes, and are functionally classified by the Pennsylvania Department of Transportation as local highways.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Board of Supervisors of Millcreek Township, Lebanon County, Pennsylvania, and it is hereby ordained and enacted by the authority of the same as follows:

SECTION ONE. A maximum speed limit of twenty-five (25) miles per hour is hereby established for the following:

- A. Portions of Edgement Lane (T-655) from a point at the southerly boundaries of Lots 168 and 167 on the recorded plans for Newburg Village to a point at the easterly boundaries of Lots 137 and 202 of those plans and from South Sheridan Road (State Route No. 2023) to Sweetwater Lane (T-663);
- B. Central Drive (T-645) from its southerly terminus at Treeline Drive (T-651) to its northerly terminus at Edgemont Lane (T-655);

- C. Cottage Lane (T-647) from its southerly terminus at Treeline Drive (T-651) to its northerly terminus at Central Drive (T-645);
- D. Garden Drive (T-449) from its easterly terminus at Edgemont Lane (T-655) to its westerly terminus at Cottage Lane (T-647);
- E. Morgan Drive (T-660) from its easterly terminus at Memorial Boulevard (T-636) to its westerly terminus at Edgemont Lane (T-655);
- F. That portion of Treeline Drive (T-651) from Village Drive (T-652) to Edgemont Lane (T-655);
- G. That portion of Sweetwater Lane (T-663) from a point at the easterly boundary of Lot 435 on the recorded plans for Newburg Village to a point at the southerly boundaries of Lots 295 and 318 of those plans;
- H. A portion of Eagle View Drive (T-662) from Sweetwater Lane (T-663) to the easterly boundaries of Lots 388 and 391 on the recorded plans for Newburg Village; and
- I. A portion of Hillside Drive (T-661) from Sweetwater Lane (T-663) to a point at the easterly boundary of Lot 362 on the recorded plans for Newburg Village.

SECTION TWO. The appropriate officers and employees of the township are authorized and directed to put in place all official traffic control devices necessary to implement the regulations established herein.

SECTION THREE. It is a summary offense for a person to violate the traffic regulations created by this ordinance. A person convicted of violating any such traffic regulation shall pay the fine established in the section of the Pennsylvania Vehicle Code on which such regulation is based. The purpose of this section is to coordinate enforcement of the regulations created by this ordinance with the Pennsylvania Vehicle Code, specifically 75 Pa. C.S. § 6502(b) and § 3362(c).
