Organization and Regular Meeting January 2, 2024

Seconded by Moyer. All aye, motion carried. <u>Signature sheets</u> also signed. <u>PLGIT check writing authorization</u> sheet signed.</u></u>

Recreation Field Rent - Motion by Moyer to keep the rental rates for 2024 the same as 2023. Seconded by Weidman. All aye, motion carried.

<u>Mileage</u> - <u>Motion by DeSantis to adjust mileage in accordance to the standard set by the IRS rate of (\$.67).</u> Seconded by Moyer. All aye, motion carried.

Newmanstown Water Authority

Motion by Weidman to re-appoint John Kantner, and William Zimmerman to another five-year term on the Water Authority. Seconded by DeSantis. All aye, motion carried.

Zoning Hearing Board

Motion by Moyer to appoint Timothy Bartow to another three-year term on the Zoning Hearing Board. Seconded by Weidman. All aye, motion carried.

Millcreek-Richland Joint Authority

Motion by DeSantis to appoint Arthur Wealand to a five-year term on the Millcreek-Richland Joint Authority. Seconded by Moyer. All aye, motion carried.

Recreation Board

Motion by Moyer to re-appoint Cody Moyer to another five-year term on the Millcreek Township Recreation Board. Seconded by DeSantis. All aye, motion carried.

Auditors

Secretary reported that we currently have 3 vacancies and no prospects. Write-ins from the election declined the position, and efforts to contact the Moll's went unanswered. Solicitor will research what needs to be done to comply with the Second-Class Township Code.

Motion by Moyer to recommend to the Auditors that they set the working supervisors pay rates for Non CDL snow \$13.50; and \$15 per hr. CDL snow plowing. Seconded by Weidman. All aye, motion carried.

SOLICITOR:

<u>Unpaid mowing</u> bills – 221 E. Park St. - Solicitor reported that the notice was sent and payment will be due by Jan. 13th. If not received a Municipal lien will be filed. 124 N. Sheridan Rd. - payment was received.

<u>Comcast franchise renewal</u> – Solicitor reported on his phone conference with Eric Wilden. Seven separate items were discussed. Five provisions still need approval from higher ups and 2 provisions were agreed upon in principle and the language is being worked on for Solicitors review.

<u>Junkyard license application</u> – Solicitor reported that the attorneys for Mr. Arias and Vince Lombardo's estate are still working on a new agreement. They hope to have it done sometime this month.

ACTION:

Resolution 1-2-2024 Appointing Garcia, Garman, & Shea, PC to replace the elected auditors was presented to the Board for their consideration. Motion by Weidman to adopt Resolution #1-2-2024 appointing the certified public accounting firm of Garcia, Garman, & Shea, PC to replace the elected auditors of Millcreek Township. Seconded by Moyer. All aye, motion carried. Letter of Understanding was reviewed and signed.

Resolution #1-2-24 B Amending the Non-uniformed Pension Plan and Adoption Agreement reducing the Contribution rate for the year 2024 - was presented to the Board for their consideration. Motion by Moyer to adopt Resolution #1-2-24 B setting the contribution rate and amending the Agreement. Seconded by Weidman. All aye, motion carried. Adoption agreement will need to be signed when received from PMRS.

Resolution #1-2-24 C Amending the Police Pension Plan and Adoption Agreement which waives the Police Contribution rate for the year 2024 was presented to the Board for their consideration. Motion by Weidman to adopt Resolution #1-2-24 C waiving the police contribution for the year 2024 and amending the agreement. Seconded by Moyer. All aye, motion carried. Adoption agreement will need to be signed when received from PMRS

UNFINISHED BUSINESS:

<u>CD-</u> rates, amounts and terms were discussed. Fulton Bank – 7 month 4.90%, 9 month 4.25% (no penalty), 10 month 5.25%, 13 month 5.10%. <u>Motion by Weidman to open a 10-month CD, at 5.25% for \$200,000 with Fulton Bank (GF). Seconded by Moyer. All aye, motion carried.</u>

<u>Road Hire</u> – Moyer reported after doing interviews, Tyler Shanaman will be coming back. He will be starting from scratch at \$22 per hour, and suggested giving him one week vacation this year. <u>Motion by Moyer to hire Tyler Shanaman at \$22 per hour, with one paid week vacation in his first year of service. Seconded by DeSantis. All aye, motion carried.</u>

<u>Disc Golf email</u> from Steckbeck discussed. Board is still interested in pursuing.

Solar Energy zoning – Planning Commission still working on it but believes that they are close.

NEW BUSINESS:

CM High proposal for traffic light maintenance for 2024 was reviewed. (\$415) Motion by Weidman to enter into agreement with CM High for preventative maintenance for traffic light for 2024 in the amount of \$415. Seconded by DeSantis. All aye, motion carried.

ROAD MASTER: Risser presented his report.

Covid pay policy was discussed. Board agreed to pay employees up to five working days if positive.

<u>BILLS/TREASURERS REPORT:</u> <u>Motion by Weidman to accept the Treasurers Report and pay the bills as money is available. Seconded by Moyer. All aye, motion carried.</u>
