Basketball Courts- Stenciling- looked into better quality stencils, Josh will order from Amazon. We will possibly use the townships sprayer and trying to get paint through them at less cost. Waiting until warmer weather *UPDATE The stencils have arrived. Justin will be setting up a date to complete the stencil project ASAP*.

Damage to park- The Wi-Fi has been upgraded and is in the maintenance shed. John getting more info, we may be able to run extender from far end of shed and have open view from there. We have the account number. Tabled until 2025 meeting. Township is looking into better security for all areas, cameras and swipe or key fob access to buildings. Cameras at Hogeland Pavillion plus several at other locations in the park. Can't do cameras in Newberg using current set-up, will look into other options for that area in the future. *Rec Board will purchase camera system similar to the system that was destroyed.* 

Noel K Hertzog playground- ADA Sidewalks will be put around the park. Planned. Date TBD John will get update at next township meeting. Start date and timeline TBD *No update* 

Playground pavilion- Township handling, received bids, no additional info however John is looking into a grant through T-Mobile for repairs and updates to existing playgrounds, i.e. fence repair, bleachers etc. *No update* 

Pickle Ball – John suggested putting Pickle Ball courts on site where Tennis once was. Can't be done due to size limitations. Space has been designated in Newburg playground area for a macadam area this could possibly be a pickle ball court. John is still looking into options- *No update*

Wooden Bleachers- in bad shape. Need new supports and new surfaces. Looking into possibly replacing them with aluminum. Update- we will be looking into getting a quote to have frames built, Hackman Welding? Then get lumber to finish. Since the bleachers are not safe, Dan suggested and we all agree, that they should be remove before spring ball begins. the bleachers. John will ask the township maintenance crew to handle that. No Update - Justin to follow up in an attempt to get them removed ASAP.

Additional Damage to park- There was additional damage to the park. The items that are damaged- Counter shutter, surveillance 8 channel system, Kwik soccer net and the Forza soccer goal 8ft x 4ft The township sent letters to the parents of children involved giving a March 31 deadline to pay for the damages. Larger of the 2 was received. Still have not received the other payment.

Discussion was had on the erection of a pole building to store the items currently in the shed that is shared by Rec and Community Center. The shed is in disrepair and a space to store the soccer goals, benches and some of the other rec supplies would be ideal. *Need to talk to Community Center Committee. No update*
