Old Business

Noel K Hertzog playground- ADA Sidewalks will be put around the park. Start date and timeline TBD. The Bid is expected to be awarded at next township meeting. *Bid was determined to be unacceptable. Will rebid the job later in the year No Update*

John is looking into a grant through T-Mobile for repairs and updates to existing playgrounds, i.e. fence repair, bleachers etc. The intended use of this grant is for existing projects. Will pursue after walking path is constructed for add-ons for the walking path area. **No Update**

Pickle Ball – John suggested putting Pickle Ball courts on site where Tennis once was. Cannot be done due to size limitations. Space has been designated in Newburg playground area for a macadam area this could possibly be a pickle ball court. John is still looking into options- Will be placed in Newburg *No Update*

A WIFI enabled dead bolt was installed on the bathroom outside entry door. It has Key, keypad and remote access. Need to install new automatic door closer. WIFI is not reliable, keeps cutting out. WIFI will not connect reliably, key pad will be used to lock door. Final cameras in place. All buildings are being monitored. Resetting unit and replacing batteries seems to have lock working as desired.

Walking path – Property lines were surveyed, will keep path as far as possible from lines, will be a bit shorter, will stay on top of the retention area. Hoping to have completed by Fall. Still awaiting start date, fall may be unrealistic due to black top unable to pour in colder weather. Wet weather may be a factor to the delay. Justin suggested we have a ribbon cutting when the walking path is complete. **No Update**

Healthy Kids Running- Will be held at the Noel K. Hertzog Memorial Fields. The scheduled dates are: Sept. 7, 14, 21, 28 and Oct. 5. A make-up date of Oct. 12 This will be the final season for the current organizer, Brittany Miller Complete. Holly Hassler will run the series next season. Will take place on April 12, 19, 26, May 3 and 10 at 4 Pm on the Noel K. Hertzog Fields. May 17 is reserved as a rain date if needed.

Soccer – 110 youth are signed up. Coaches meeting on Aug. 5th, practice begins the week of Aug. 11th, the first game is Sept, 5th and will run to Oct 24th Soccer started on Sept. 5th and is going well. **Season is over and was a success.**
