- 1. 105 Cocalico Road. Commission members had no comments or concerns. Lebanon County Planning Dept. stated in an August letter they "believe the plan merits review and approval by the Township." We signed the plan.
- 2. Newswanger Ag Operation. Members reviewed the plan to construct a new equipment storage barn, equipment shop, and gravel pads prepared by Nye Consulting Services Inc. (NCS) and the Sept 17, 2025, letter from Bolt Engineering, LLC to the Lebanon County Planning Department. No issues or comments were raised by the Commission members.

New Business:

- Chase Hogeland Ag Operation. Members made an initial review of the Plan prepared by Nye Consulting Services Inc. (NCS) to erect four (4) Poultry barns. No initial concerns were identified.
- Pal Sing, 117 E Main St. Members reviewed a "Proposed Conditions Plan" showing water connections, parking layout, etc. The Plan shows 39 parking spaces to support apartment tenants, a store and restaurant. Commission members raised a concern as to sufficient driving space through the parking lot for trucks delivering supplies to the businesses. Mr. Singh did not think that would be a problem.
- Elwayne Weaver, 20 Hackman Rd. Construction of two poultry barns. Plans were submitted this week
 to the Lebanon County Planning Dept. The Plans are being developed by Nye Consulting Services Inc. (NCS)
 Commission members saw a Resource Map and Grading Plan. We await the full Plan for further review.
